This is the annual report for 2017, Audubon's 120th year of protecting birds, other wildlife and their habitats through conservation, education and advocacy.




Audubon is blessed to have dedicated and generous supporters like you. The following pages, which include the financial statement for the past fiscal year as well as the names of our donors is evidence of that.

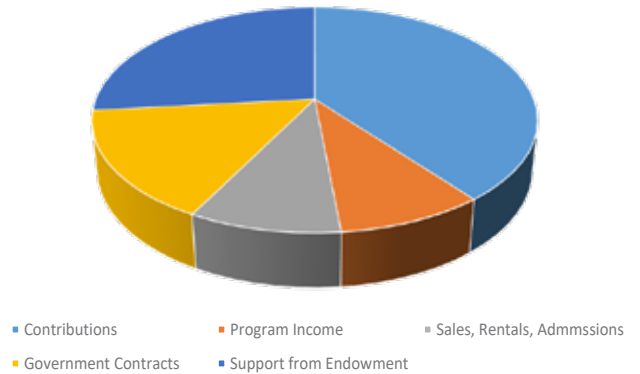

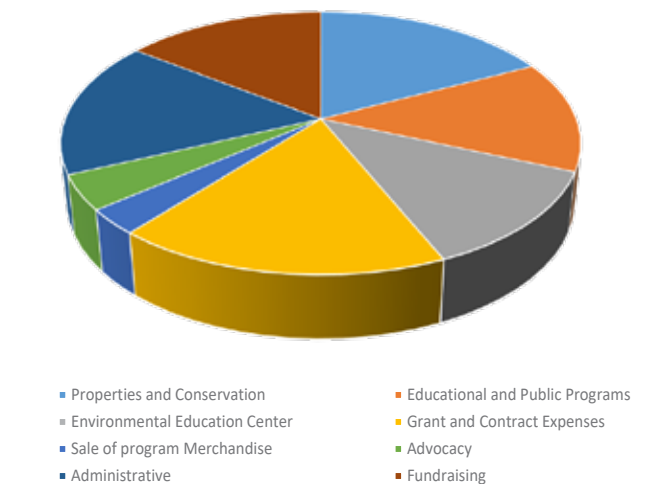
