Please submit testimony as soon as possible. Written testimony should often be **under one page** (ideally in PDF form) and limited to one issue. **Always be polite and positive** and do not attack or threaten anyone in the legislature. Make it your own as much as possible!

- Say your name and the town you live in.
- Please reference your support for H-7783, which would fully ban second generation anticoagulation rodenticides in Rhode Island.
- Salutation
- Address your testimony to the House Environment and Natural Resources Committee

First paragraph:

- In your own words, state the purpose of your letter and your position on the issue.
- Highlight your own experiences, appreciation, and passion with wildlife impacted by rodenticides here in Rhode Island. Speak from your heart!

Second Paragraph

- Offer *support* for fully banning rodenticides. Personalize it to your own reasons whenever possible. Here are some potential talking points:
 - Rodenticides are proven to have devastating consequences on the ecosystem, negatively impacting local wildlife populations, degrading water, soil and plant communities and reducing local and regional biodiversity.
 - o Safer, more humane alternatives exist that are more sustainable.
 - Write about any personal experience with what wildlife you've noticed have been impacted in your community or any actions you've taken locally already to try to stop it.
 - If you're a wildlife rehabilitator, veterinarian, or something similar make sure to mention such and discuss your personal experience with the impact of rodenticides.

Conclusion

• Thank the committee for hearing your concerns. Ask them to support your position, for example, "Therefore, I urge the committee to support H-7783 to fully ban second generation anti-coagulant rodenticides across Rhode Island.
